All # picks will be made in numerical order after the puppies have reached 8 weeks of age.

The above said American Bully Puppy is sold to the above "Buyer" for the total price of _____. A deposit in the amount of _____ U.S. By form of Cash, CashApp, PayPal, or Wal-Mart to Wal-Mart is hereby made and the cash balance is due to Seller before the dog is placed in the Buyer's possession or before 8 weeks of age whichever is first. Registration papers will also be held until the balance is paid in full, after which the seller will hand over the puppies American Bully Kennel Club puppy registration papers, papers will be mailed to buyer within 3 months of purchase if not given at time of pick up or shipment of puppy.

The buyer understands that once a deposit is made, it is a commitment to buy said dog or pick # and is therefore NON-REFUNDABLE unless there are not enough of the selected sex born. Buyer will forfeit deposit and said dog or pick # may then be re-sold if not paid in full by specified date being 8 weeks of age. If for some reason you no longer wish to purchase said dog your deposit is LOST! It may NOT be transferred to another litter for another puppy. Buyer understands that the above puppy must be shipped or picked up by the age of 9 weeks unless agreed in writing by seller to hold the puppy for a longer time period. Any puppies not shipped or picked up by the buyer will incur all additional boarding fees and added cost for care by Beltline Bully Camp, LLC for providing Shelter, Food, deworming's , and additional vaccines, unless agreed upon prior to.

PUPPIES HAVE BEEN VET CHECKED AND ARE IN GOOD HEALTH, CURRENT ON VACCINATIONS, AND FREE OF DISTEMPER, PARVO, PARAINFLUENZA, AND ANY LIFE THREATENING GENETIC DEFECTS. WE DO NOT GUARANTEE AGAINST HIP OR ELBOW DYSPLASIA. CUSTOMER CAN HAVE THEIR STATE LICENSED VET CHECK THE HEALTH OF THE PUPPY TO VERIFY THE STATE OF HEALTH AT BUYERS EXPENSE. IF NOT SELLER WILL NOT BE HELD RESPONSIBLE FOR ANY ISSUES THE PUPPY MAY INCUR BEFORE IT'S FIRST LITTER PERIOD. SELLER AND BUYER AGREES IF THE PUPPY DIES FROM ANY GENETIC/HEREDITARY ISSUES EXCEPT ELBOWS AND HIPS. SELLER WILL REPLACE PUPPY OF EQUAL VALUE STATED IN THIS CONTRACT. SELLER HAVE THE RIGHT TO REQUEST HEALTH RECORD WITH DEATH AUTOPSY FOR THIS TO BE HONORED.

IT IS HEREBY AGREED BY BOTH PARTIES THAT THE FOLLOWING CONDITIONS WILL BE MET AND THAT NO OTHER WARRANTIES OR CONDITIONS ARE EXPRESSED OR IMPLIED.

1) Seller guarantees the said dog/puppy is an offspring of the previously mentioned Sire and Dam. Seller DOES NOT guarantee the color or size of the said dog/puppy.

** WE DO NOT GUARANTEE AGAINST ANY SKIN OR COAT PROBLEMS. **

2) Buyer certifies that he/she is not acting as an agent for another individual in the purchase of this dog/puppy, and will not sell to a puppy mill.

3) Both parties agree that NO DOGS/PUPPIES HAVE BEEN SOLD FOR

FIGHTING OR ANY ILLEGAL PURPOSE. If the buyer is found to be using the pup for illegal purposes or activities, or if the puppy is NOT kept in a safe home, without adequate food, or care we reserve the right to regain possession of the pup.

4) Buyer agrees to provide for this dogs emotional, mental and physical care, including all puppy vaccinations and annual physical examinations and recommended vaccinations by licensed vet: nutritious foods etc.

5) Seller strongly recommends providing proper socialization opportunities for puppy/adult. Seller shall not be held responsible for the actions of a dog that are due to buyer's negligence.

6) Seller recommends neutering males and spaying females at the age of 6 months, unless dog is to be bred or is intended for breeding purposes. Altered dogs typically live a healthier life and generally have fewer behavioral problems.

7) Buyer agrees to inform the seller if the buyer intends to sell or transfer ownership to a third party. If so the original buyer is responsible for the third party to fulfill this contract. Buyer agrees to give seller First option to resume full ownership at a price and/ or terms mutually agreed upon by both parties. This would take into consideration the cost incurred by the breeder in caring for the dog and locating a new home. The dog will be returned with it full registration and any medical records. The seller has 10 days to accept or reject this right of first offer. If this dog at any time in its life needs to be surrendered at no cost, the buyer will reclaim this dog, and its disposition becomes the choice of the breeder / seller. Under no circumstances is the dog to be placed in a pet shop, animal shelter, or other similar establishment.

8) Should buyer be unable or unwilling to fulfill any of the above agreements, or if dog is seized by local authorities, as having been neglected abandoned, the seller retains the right to reclaim the dog without compensation. Buyer agrees to pay seller any and all expenses including court cost and reasonable attorney fees, in enforcing the terms and provisions of this contract.

Canines are livestock and therefore cannot be returned for any reason other than those stipulated in the health agreement or additional terms and provisions section of this contract. All sales are final.
